DNA testing is required for all breeding horses. HYPP is required for descendants of Impressive born in 2007 and after. Refer to AQHA rules REG109.8, REG109 and REG108 for other testing requirements. AQHA offers a five-panel test for HYPP, GBED, HERDA, PSSM1 and MH. The effects of these diseases are wide-ranging, from mild and manageable to severe and terminal.
